# INFORMATION FOR Street Vacation Process

This summary outlines the procedure for filing a Street Vacation application in the City of Edmonds. A Street Vacation is a procedure in which the city may relinquish its interests in a street, alley or easement. Upon receipt of an application, the City will determine whether the right-of-way is no longer necessary for public use.

## CODES

Edmonds Community Development Code Chapter 20.70.

## **CRITERIA**

The city council may vacate a street, alley, or easement only if it finds that:

- 1. The vacation is in the public interest; and
- 2. No property will be denied direct access as a result of the street vacation.

#### FEES:

Application fee for a Type V decision as identified in the Planning and Development Fee Schedule. Monetary compensation as applicable.

## MINIMUM SUBMITTAL REQUIREMENTS

- 1. A vacation petition with supporting affidavits on forms provided by the planning division;
- A legal description of the street, alley, easement, or part thereof to be vacated. This legal description shall be prepared by a surveyor registered in the state of Washington;
- A scaled site plan showing the street, alley, easement or part thereof to be vacated and showing all properties with subdivision, block, lots, and specifying open and unopened rightsof-way for a radius of 400 feet from the street, alley, easement, or part thereof, to be vacated;

- An appraisal prepared by a qualified land appraiser with an M.A.I. designation, establishing the fair market value of the street, alley, or part thereof to be vacated;
- 5. A completed application and fee as established by ordinance;
- 6. If the property was originally dedicated by one and only one of the abutting properties, the designation of the property from which the right-of-way was dedicated; and
- 7. Any additional information or material that the manager of the planning division or his/her appointee determines is reasonably necessary for the city council to consider the requested vacation.

### **PUBLIC HEARING AND DECISION**

- 1. Planning Board. The planning board shall hold a public hearing and make a recommendation to City Council.
- City Council. The city council may consider the planning board's recommendation in a public hearing. The council may approve, deny or modify the requested amendment. Final decision per City Council.
